





## PWW Services Make A Return to Oakdale after Renovations

After making significant interior renovations, our groups were thrilled to be back and participate in cooking and hygiene classes! These renovations helped to make the space more welcoming and hospitable for group activities, classes, and providing services.

## Food Pantry Volunteers from FREE Help Support Our Community

Throughout the year, FREE's PWW and Pre-Vocational groups have been volunteering at our food pantry at FREE's Brentwood location. Each day they have been collecting donations from Island Harvest, stocking the shelves, and serving customers. ## Pre-Vocational Services Car Wash Fundraiser at FREE Oakdale

Our Community Pre-Vocational program had a fantastic experience hosting a car wash, where participants honed their customer service and money management skills. They were busy washing over 35 cars, and the funds they raised not only covered lunch for the day but also supported their Pre-Vocational programming!

# Behavioral Health Services

FREE is dedicated to delivering Behavioral Health services to individuals in need. With extensive experience supporting those living with serious and persistent mental illness (SMI), including individuals with legal or forensic backgrounds, co-occurring substance use disorders, and developmental disabilities, FREE has built a reputation for compassionate and comprehensive care. Over the decades, we have cultivated strong, enduring partnerships with a wide range of providers to enhance our services. FREE remains steadfast in its commitment to offering housing and support to individuals with SMI, embracing those with cooccurring disorders as part of our inclusive mission. FREE Inc. currently operates an Article 31 Integrated Program and Article 32 Outpatient Program, allowing all referrals that need substance use services to be referred directly to our Clinic in Oakdale, NY. In the last year, FREE has increased the Integrated Program census to 102 clients allowing innovative types of care to those that are dual diagnosed with substance use disorders. Our Outpatient Programs makes information available in English and Spanish.

FREE offers extensive outpatient programing through the Office of Mental Health. Our Personalized Recovery Oriented Services Program serves adults aged 18 and over and is primarily group-based therapy with individual and group counseling. Service provisions are available in all different areas including Wellness Self-Management (coping with stress, coping with anxiety, art therapy), Basic Living Skills (budgeting, communication skills), Employment Related Skills, and Community integration.

FREE operates Community Oriented Recovery and Empowerment Programing to those who seek more individually based mental health services who don't prefer working in group settings. Our CORE Program has reached over 102 people this year alone, providing services to those clients within their homes and communities with severe and persistent mental illness.

The Children's Mental Health Clinic has significantly expanded its census, having served 83 children this year. The clinic has also broadened its service offerings to include group therapy sessions for both families and children, art therapy sessions and medication management along with new Saturday appointment availability.

## Wyandanch School District Satellite Site and Clinical Support

The Children's Mental Health Satellite Site launched in Quarter 4, providing essential services to the Wyandanch School District two days per week, five hours each day. In addition, a \$25,000 Department of Justice grant was secured to enhance clinical support for children in Wyandanch, enabling the creation of after-school therapeutic social skills programs running eight hours per week.






## Terry's Place PROS Receives \$15,000 Grant from Senator Thomas

Terry's Place PROS continues to implement the Individualized Placement and Support Employment Service provision.

All participants received new clothing for upcoming job interviews and employment opportunities from a Department of Justice Grant for \$15,000 from New York State Senator Kevin Thomas.

## Partnership with Nassau BOCES and Nassau Community College

Terry's Place PROS began a partnership with Nassau BOCES and Nassau Community College to provide services to the graduating class of 2024 and for future BOCES graduates. The outreach efforts and improved efficiencies resulted in a 36% increase in revenue.





#### **Article 31 Clinic Expansion**

During the 1st quarter of 2024, the Community Services Division implemented targeted initiatives to improve service delivery, census, and to optimize revenue. The Article 31 clinic improved efficiencies in caseload size, intakes, and appointments. Throughout the year the clinic supported 1,081 people.

# Traumatic Brain Injury (TBI)

The Traumatic Brain Injury (TBI) waiver program is grounded in the philosophy of providing individuals with complete freedom of choice. To advance its mission, the Structured Day Program focuses on building essential skills for maintaining competitive employment or volunteer roles within the community. We are excited to share that the TBI Structured Day Program has successfully expanded its reach, supporting more individuals and creating increased opportunities for community engagement.

Participants in the program develop vital skills, such as effective communication, customer interaction, task focus, attention to detail, and professional appearance. The structured day begins with individual work upon arrival, followed by group activities centered on job readiness topics or skill-building. The day concludes with either additional individual work or a group activity chosen by the participants. Additionally, the group enjoys organizing special outings to connect with the community, such as visiting museums, shopping, or taking a relaxing walk in the park.

This holistic approach fosters personal empowerment, greater independence, meaningful community inclusion, self-reliance, and productive engagement. We are excited to continue expanding our program in the coming year to support even more individuals on their journey toward growth and fulfillment.

# Addiction Services and Supports



## Silent Killers: Fentanyl and Xylazine Community Event

On March 26, 2024, The Success Integrated Outpatient Program hosted their first community awareness event "Silent Killers: The Danger of Fentanyl and Xylazine" with guest speaker Suffolk County Assistant District Attorney, Nicole Felice.



## FREE Becomes Official Provider of Offending Driver Program

The Offender Driving Program received approval from the Office of Addiction Services and Supports (OASAS), and FREE is now officially recognized by the DMV as a certified provider for assessments and clinical services for mandated individuals.

FREE Inc.'s Substance Use Disorder Program is expanding significantly, with efforts to introduce specialized groups for co-occurring and addiction disorders. Recruitment has been enhanced by revamping salaries for Credentialed Alcoholism and Substance Abuse Counselors (CASACs), and the program partnered with the Suffolk County District Attorney's Office to present on emerging drug trends. A CASAC has been on-boarded to manage a caseload of 33 clients, while a grantfunded Service Coordinator now supports 31 individuals. Additionally, the Offender Driving Program received approval from the Office of Addiction Services and Supports (OASAS) and is now DMV-certified for mandated assessments and clinical services. These developments underscore FREE Inc.'s commitment to addressing substance use and mental health needs in the community.

An OMH Housing and Clinic Collaboration group was established to further support those that live within FREE's OMH Housing Programs. This group targets those with a dual diagnosis (MI & SUD) that are not receiving clinical services in an effort to treat their substance use. Certified Homes have been identified as having frequent and active users and group curriculum has been developed for the Integrated Outpatient Services (IOS) to provide services on-site in their homes. This action, curriculum and collaboration was established and created to expand service provision and increase census at the SUD Clinic.


